Tremendous growth has been experienced in this sector of the industry with increasingly tighter financial constraints due to the challenges of the economy. This course is designed to provide students with management skills and analytical methods applicable to today's general aviation industry. Analysis will be developed in the area of planning, organization, directing and financial controlling. In depth study will be in the areas of marketing, flight operation organizational structures, financial analysis, maintenance management, risk issues, environmental concerns and human resource constraints. Concepts will be explored through text readings, case studies and current news events.
