

Annual Report 2021-22 Department of Justice Studies San José State University



Introduction

In the academic calendar, the arrival of Spring marks the end of the year. It is a time for celebrating achievement and the Department of Justice Studies has a lot to celebrate. Our students have completed degrees, earned honors, received scholarships, and won awards. We are proud of Kelly Prashar, named SJSU's Outstanding Graduating Senior for 2022. She received one of only two of these awards given to 7,500 Spring graduates across the university.

Our faculty have delivered excellent degree programs, given invited presentations, and provided interviews for news stories; faculty have assisted organizations, published research, and secured grant funding. Peggy Stevenson and the RCP team acquired more than \$1.3 million for the Record Clearance Project this year, with more grant applications pending.

The end of the academic year is also a time of transition. Graduates leave us to begin careers, or continue their study in law school or graduate school. We will lose some faculty colleagues as well. Professor Steven Lee, the founder of our forensic science program, has retired after two decades at SJSU. See Mary Juno's interview with him in the Spring 2022 issue of *Themis*.

We completed a search for new faculty, and next year, we will welcome two new assistant professors. Justin Strong, a PhD candidate in Criminology, Law and Society at the University of California-Irvine, will join us in January 2023. Andrea Martinez, with a PhD in Criminal Justice from the John Jay College, City University of New York, will join us in August 2023. During 2022-23, she has a post-doctoral research fellowship to study Chicano gang members deported from Santa Barbara, California, to Tijuana, Mexico.

Finally, the end of the academic year is a time of reflection, for thinking about the year ahead and making plans. During 2021-22, we started our five-year review of programs. We completed our self-study in December, and had a visit from our external reviewer in May. Madelaine Adelman, associate professor of Justice and Social Inquiry at Arizona State University, helped us advance our programs and extend opportunities.

And, speaking of next year, we will be celebrating twenty years of Justice Studies and Forensic Science at SJSU. In 2003, the Department changed its name from Administration of Justice to Justice Studies, and started the program in Forensic Science. We will announce several events to mark these anniversaries and hope you will be able to join us.

Student Honors

The Honors Convocation at SJSU each Spring recognizes students for outstanding academic achievement. To be recognized as a President's Scholar, a student must have a 4.0 GPA for the Fall or Spring semester prior to graduation. To be recognized as a Dean's Scholar, a student must have a GPA of 3.65 or higher in at least two contiguous semesters.

In May 2022, SJSU Interim President Steve Perez recognized 85 graduating seniors from the Department of Justice Studies as President's Scholars: 8 in Forensic Science-Biology, 7 in Forensic Science-Chemistry, 2 in Forensic Science-Digital Evidence, 23 in Justice Studies, and 44 in Justice Studies-Criminology.

There were 299 Dean's Scholars from the Department of Justice Studies: 26 in Forensic Science-Biology, 18 in Forensic Science-Chemistry, 2 in Forensic Science-Digital Evidence, 98 in Justice Studies, and 155 in Justice Studies-Criminology.





Record Clearance Project

The Record Clearance Project, founded in 2008 by Peggy Stevenson, is the only clinical program in the USA that engages undergraduate students in providing legal services. RCP students learn and use legal skills, under attorney supervision, to assist members of the community in expungement law and procedure. RCP has filed more than 1,850 petitions to dismiss convictions on behalf of 800 clients; RCP has trained more than 750 future lawyers, law enforcement, probation officers and others committed to public service.

Peggy Stevenson and Judith Randle trained 14 law students at Stanford Law School in November 2021; the students joined with SJSU students to carry out 32 interviews for the Record Clearance Project.

During 2021-22, RCP assisted 101 clients at six speed screening sessions, to review criminal history and inform them about the next step in clearing their records, and gave 16 legal rights presentations to 302 people in jail and the community about the right to clear their record.

Law students from Stanford University, the University of California-Berkeley and the University of California-Los Angeles joined RCP students to work on nine cases during Alternative Spring Break in March 2022.

The P2E mentoring team, led by Cindy Parra, pairs clients with mentors to assist them in gaining life skills. From July 2021 to April 2022, P2E connected 116 clients at 1,486 times to services needed to attain self-sufficiency.

California Senator Scott Wiener cited RCP in proposed legislation in a statement about the value of expungement of criminal records. SB 1106 would make it possible for record clearance in cases where victim restitution has been ordered.




Justice Studies Task Force
