COURSE FORMAT

CATALOG DESCRIPTION

Introduction to qualitative research methods used in Justice Studies. Includes relationship of empirical evidence to theory, ethics in conducting empirical research, methodological design, interviewing techniques, field methods, participant observation, and content analysis.

COURSE DESCRIPTION

The purpose of this course is to familiarize students with research techniques necessary for systematic analysis of the criminal justice system, offender behavior, crime trends, and program effectiveness. Students will learn to critically evaluate existing research, and will become familiar with existing sources of criminal justice data and will learn to assess the quality of that data.

COURSE GOALS

The Department of Justice Studies is committed to scholarly excellence. - ✓ Effectively conduct a review of research literature; and
- ✓ Articulate course concepts in both written and verbal form.

Many of the elements of this course will help students improve skills such as critical thinking, problem solving, and constructing an argument. These important skills can be carried over into the non-research aspects of everyday life.

COURSE REQUIREMENTS AND ASSIGNMENTS

Online Discussion (20%): Active participation in discussions is a necessary and integral part of the course. Readings will be routinely assigned from the selected course textbook and outside articles and other materials will be assigned to supplement the textbook. Discussion questions pertaining to these readings and other course concepts will regularly be assigned throughout course.

Assignment 1 – Creating a Bibliography (5%): Students will create a bibliography for citing journal articles in a referencing software (i.e., EndNote or Zotero). Detailed instructions for this assignment are available on Canvas. This assignment is due Sunday March 7th.

Assignment 2 – Using Secondary Data (5%): This assignment will require students to access and present crime data that have been collected and reported by government agencies (e.g., the Federal Bureau of Investigation). Detailed instructions for this assignment are available on Canvas. **This assignment is due Sunday April 11**th.

Assignment 3 – Peer Review (5%): Prior to submitting their own research, students will critically evaluate the research of one classmate and provide constructive feedback. Detailed instructions for this assignment are available on Canvas. **This assignment is due Sunday May 2**nd.

Assignment 4 – Research Paper (50%): Each student will conduct and report original research, accounting for the most significant portion his/her course grade. Detailed instructions pertaining to this assignment are available on Canvas. Draft sections of the research paper will be submitted throughout the semester (see the Course Schedule), with the final paper due Sunday May 9th.

Quizzes (15%): Students will complete three quizzes during the semester, each worth 5% (totaling 15%) of their final grade. Each quiz will cover material from the lectures (including all media presented) and the assigned readings. The quizzes will be comprised of multiple choice, true/false, and short-answer questions. The date of each quiz is indicated in the Course Schedule.
