

Professor Annette Nellen participated in several virtual conferences since spring including the AICPA Engage conference in June (COVID-19 law undoing of TCJA) and National Tax Conference in November (tax updates, plus tax doctrines for tax geeks part 2). She also spoke to the National Society of Accountants (on ethics) and the Minnesota State Bar Association (taxation of virtual currency). Annette's article, "Now is the Time To Start Fixing the Sales Tax Base," was published in *Tax Notes State* in September 2020. In August, the AICPA appointed Annette as co-chair of the Tax Compliance & Planning Discipline Task

Force that will work to develop curriculum ideas related to the significant changes underway to the CPA exam.

### ALUMNI NEWS Leigh Ann Moore, CPA, MST



Leigh Ann Moore, CPA, MST, is Director of Tax Operations at Netgear, Inc. A SJSU accounting program graduate, she began her career as an auditor with Ernst & Young in San Jose where she earned her CPA. After working in financial accounting for several years, "I crossed over into tax and never looked back. I love the challenging work!"

At Netgear, Leigh Ann is focused on ASC 740 tax accounting, the federal & state income tax return compliance cycle, and management of the sales and use/property tax processes. She considers herself a corporate tax generalist after having developed these skills during roles with National Semiconductor, the IRS, Intuit, Xilinx, and eBay.

"I've been very fortunate in my career to have worked at organizations with incredibly interesting issues and amazing colleagues, giving me a broad background in corporate taxation. I really enjoy teaching and mentoring staff because I remember the first time I tackled these issues and needed guidance." Leigh Ann didn't enter the MST program until later in her career, after working as a single mom raising her two daughters. "The MST program was always a goal of mine, and it allowed me to really solidify my understanding of the underlying principles of taxation in a cogent way. It would have been great to have had that theoretical understanding from the start, but it's never too late."

Her advice for MST students is to be a life-long learner. "I've maintained my certification throughout my career, enjoying classes though TEI, the CalCPA Society, SJSU High Tech Tax Institute, or firms' webcasts. And, embrace tax technology – tax is always changing." She also advises to "fill your bucket with the big rocks" by making sure you focus on key skill sets at each position. "It may not be your dream job, but if you take on something specific from each opportunity, that's how you build your career." Outside of work, Leigh Ann enjoys hiking, gardening and traveling. A favorite trip was a 2week drive/stay through New Zealand in 2019. "I plan to get back out there post-Covid!"
