Syllabus

Required Texts: *Introduction to Logical Reasoning Bible* (LR), *Logic Games Bible* (LG), *Plain English for Lawyers* (PE)

Course Description: Basic concepts of logic; goals and standards of both deductive and inductive reasoning; techniques of argument analysis and assessment; evaluation of evidence; language and definition; fallacies. This particular section will be addressing all these skills and concepts as they are relevant to the Law School Admission Test and the first year law school experience. **GE:** Area A3: Basic Skills, Critical Thinking

Requirements: homework (to be turned in at the beginning of class on the day assigned below. NO LATE homework will be accepted); 2 midterms, 1 final, 1 case brief, 4 memos (2 rule based reasoning papers, 1 analogical reasoning paper, 1 statutory reasoning paper)

Exams: Most of the exam questions on LR and LG will come from the two texts. They will be from the LSAT questions that we did NOT cover in class.
