Joey Ruth asked for any objections to approve Ms. Bates, Mr. Yila, and Mr. Solorzano as the recommendations to the Board for the Student-at-Large positions.

Seeing no objections, Mr. Ruth noted that the Personnel Committee approves by unanimous consensus a recommendation the Board to approve Ms. Bates, Mr. Yila, and Mr. Solorzano as student-at-large members for the Student Union Board of Directors.
