Kristin Kelly informed the Personnel Committee members that management is asking that the Personnel Committee approve the following amendments to the SUSJSU 403B Plan due to the Student Union subsuming the Associated Students' Campus Recreation department Ms. Kelly noted that the requested amendments are: that the date change to July 1, 2016; addition of the three full-time employees from sister organization; and the exclusion of any employees that are non-students who work less than "x" number of hours per year. Ms. Busalacchi noted that the Student Union worked with the employment attorney to survey the intermittent employees and the number of hours worked to arrive at the "x" amount of hours worked per year.

Laura Sullivan-Green moved to approve the amendments to SUSJSU 403B Plan as presented.

Sameer Saran seconded the motion.
